

SALES

All proceeds from sales belong to the exhibiting artists. Appropriate sales taxes must be collected and paid by the artist. Flushing Women's Club is not responsible for the collection or payment of any sales taxes.

SETUP

Registration booth opens at 6:00 am, Saturday, June 2nd, 2018. You will receive your exhibitor's packet which will include your booth number and any necessary information at the registration booth. All photographs will be returned in your exhibitor's packet

Vehicles are allowed on the fair grounds for setup and tear down. However, no vehicles are permitted in areas other than designated parking between 8:30 am and 4:00 p.m., A limited number of booths are available with parking on a first come, first serve basis.

This show is held outdoors, rain or shine. Booth space is preassigned. Artists must furnish their own tables, tents, etc., and must fit within the 12' x 12' booth space, Electricity is not provided or available. All tents must be staked down.

Show starts at 9:00 am. A consistent display must be maintained to show end time of 4:00 p.m.

Complimentary coffee and muffins will be provided for artists until 9:00 am.

ARTWORK

All artwork must be the artist's original conception. It must also be suitable for an arts and fine craft show and must be designed and executed by the accepted artisan. Artists may show only work in categories accepted by the Flushing Women's Club.

All prints must be from the artist's original work and processed by the artists or under their direct supervision. **Absolutely no wholesale, imported or commercial goods, molds or casts will be allowed.** Flushing Women's Club reserves the right to disqualify and/or remove vendors who violate these rules.

Please submit a minimum of **two photos of your artwork, one photo of you creating your art and one photo of your booth with artwork displayed.** Each photo must have the artist's name, address and artwork description on the back. Photos must be representative of the type of items actually being sold.

REGISTRATION:

Send your application form, the required photos or slides of art and a check or money order in the amount of \$65 per booth payable to: "Flushing Women's Club"
A maximum of 150 booths are available. **Please be courteous and submit your application early to eliminate last minute stress on the chairperson.** Applications will be accepted until all booth spaces are filled. Stand-by applicants will be notified as space becomes available. Deposit of your check will verify acceptance in the show, if not accepted, the registration fee and photographs will be returned, **No refunds for cancellations will be issued after May 1st, 2018.**

ADVERTISING:

Flushing Women's Club will be further expanding our advertising campaign. Advertising will include television, newspaper, posters and electronic media.

AWARDS:

Best of Show will be awarded one complimentary booth space for 2019 Art in the Park.

Winner will be decided the day of the show by a selected committee based on creativity, style and booth presentation. The winner will receive a "Best of Show" certificate the day of the show.
